AND: AMERICAN FRIENDS OF BNOT TORAH INSTITUTE, for itself and as representative of BNOT TORAH INSTITUTE (Israel) (Hereinafter: "BTI")

**CONSENT**

The Parent hereby gives full consent to his/her daughter \_\_\_\_\_ (Hereinafter: "the Student") to travel to Israel and study in BTI's program of study for the 2023/2024 academic year (Hereinafter: "the Program").

**PROGRAM DATES**

The program will be conducted from August 28, 2023 - June 7, 2024.

**BTI COMMITMENT**

BTI hereby agrees to enroll the Student in the Program for the referenced Program dates and provide the Student with instruction, formal and informal activities, breakfast, a light lunch & supper on school days, as well as residential facilities during the period of the Program.

**REGISTRATION**

In order to register in the program, this contract must be signed, notarized and submitted together with a **non-refundable** registration fee of \$4,000.00.

**PROGRAM COSTS**

The Parent undertakes to pay to the American Friends of Bnot Torah Institute the annual Program Costs of attending BTI. Program Costs include tuition, residence costs - including all utilities, breakfast, light lunch & supper on school days - for those students interested in participating in our meals, as well as school sponsored tours and activities.

**REGISTRATION SERVICES NOT INCLUDED IN THE PROGRAM COSTS**

The Program Costs do not include the costs of transportation to and from Israel, living expenses in Israel (excluding room and utilities) or any incidental expenses. The Parent shall bear these costs, as well as all medical or pharmaceutical expenses.

In order to assure proper medical care and hospitalization insurance for the student, the Parent agrees to enroll the Student on the American Israel Medi-Plan, on either the (AIM) Gold Plan (Early registration until August 1, 2023 - \$595.00; thereafter -\$650.00) or the more comprehensive Platinum Plan. (Early registration until August 1, 2023 - \$695.00; thereafter -\$750.00)

**PAYMENT SCHEDULE**

The Parent will provide BTI with post-dated checks for Program Costs according to the dates and amounts listed below:

***REFUND POLICY***

If the student either withdraws from the Program or is dismissed for disciplinary reasons, the Parent will be entitled to a partial refund of the Program Costs based on the following schedule.

Should the Student leave the Program prior to August 1, 2023, the Parent will be entitled to a full refund of the Program Costs. (The registration fee of \$4,000.00 is non-refundable.)

Should the Student leave the Program on or after August 1, 2023, but prior to August 28, 2023, the Parent will be entitled to a 75% refund of the Program Costs.

Should the Student leave the Program on or after August 28, 2023, but prior to September 28, 2023, the Parent will be entitled to a 60% refund of the Program Costs.

Should the Student leave the Program on or after September 28, 2023, but prior to October 27, 2023, the Parent will be entitled to a 35% refund of the Program Costs.

Should the Student leave the Program on or after October 27, 2023, but prior to November 27, 2023, the Parent will be entitled to a 20% refund of the Program Costs.

Should the Student leave the Program on or after November 27, 2023, the Parent will remain responsible for payment of the full Program Costs.

***LIMITATION OF LIABILITY***

BTI, its agents and employees, shall not be liable in any manner or degree for loss or damage sustained to the Student's personal property for any reason. It is understood that BTI shall in no way be deemed responsible for the operation or management of any means of transportation, public or private, or facilities used or enjoyed by the Program unless directly owned by it.

***EMERGENCY TREATMENT***

If in the opinion of a duly licensed physician, the Student shall require emergency medical, dental or surgical treatment which requires the prior consent of the Parent, the Parent hereby authorizes, appoints and empowers BTI to act as his agent and to give such consent and the Parent hereby releases and agrees to indemnify and hold harmless BTI from any and all liability in any manner arising out of the giving of such consent.

***STUDENT ACKNOWLEDGMENT OF CONTRACT CONTENTS***

I hereby accept the terms and conditions of this contract and agree to be bound by all of its provisions. In addition I state that I have read the BTI Student Registration Guide, including the Code of Conduct, and agree to abide by all the rules and regulations of BTI during the course of the Program.
